Applicant hereby agree(s) to release the City of Staunton of any and all liability of any kind or nature in any rights, cause of action or claim of any kind or nature, other than the City’s own negligent action or omission, which may accrue as a result of Applicant’s business operation under the terms of the license.

Applicant agree(s) to furnish to the City of Staunton a certificate of insurance evidencing: (1) a commercial general liability insurance policy in the minimum amount of \$1,000,000.00 and (2) a comprehensive property damage insurance policy in the minimum amount of \$100,000.00, each naming the City of Staunton as an additional insured under its terms so as to indemnify the City of Staunton from any covered liability that Applicant agree(s) to hold harmless from as set forth herein.
